Members are respectfully asked to advise the Proper Officer, prior to the meeting, if they are unable to attend.

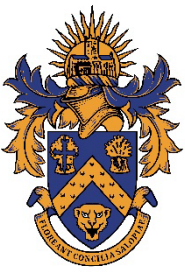
