<sup>&</sup>lt;sup>1</sup> Under the Localism Act 2011 (ss1-8) and SI 965 The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012 a Council may adopt the General Power of Competence if it meets the following criteria: Two thirds are elected members; It employs a suitably qualified Proper Officer, and that the Proper Officer has undergone relevant training (NALC) in GPC. Although this resolution is only required at the Annual Council Meeting following an election, i.e., every four years, it is included here due to several personnel changes at the Council since the Power was adopted at the Annual Council Meeting of 10<sup>th</sup> May 2021.
