

# **ANNUAL COUNCIL MEETING**

## MINUTES OF THE ANNUAL COUNCIL MEETING HELD ON WEDNESDAY 15TH MAY 2024

Councillor A. Hall opened the meeting at 7.15pm, as Chairman for the 2023/24 Civic Year.

#### 1. To elect the Town Mayor (Chairman of the Council)

After a nomination by Cllr R. Hall, seconded by Cllr Sullivan, it was unanimously **RESOLVED** to elect Cllr A. Hall as Town Mayor for the 2024/25 Civic Year. **WTC/FC/ACM/01/2425** 

2. To receive the elected Mayor's Declaration of Acceptance of Office

Cllr A. Hall read and signed the Declaration of Office, witnessed by the Proper Officer.

3. To elect the Deputy Town Mayor (Deputy-Chairman of the Council)
