7. Governance Matters: Armed Forces Community Covenant Pledge

To consider and resolve to support our Armed Forces through commitment to the Armed Forces Community Covenant. The Covenant aims to bring together the Armed Forces community and the civilian community on a local level, nurturing mutual understanding.

8. Amenities & Events Committee: Resolution WTC/AE/03/2435 – Declaration of Climate Emergency

To ratify resolution WTC/AE/03/2425 of the Amenities & Events Committee (19th June 2024) to inform future Town Council decisions and community engagement:

Aligned to WTC Biodiversity Policy (WTC/FC/33/2324 – 20th DECEMBER 2023) and in common with other Town, Parish and County Councils, to resolve that Whitchurch Town Council recognises the impacts of climate change through the declaration of a "Climate Emergency", and further resolves to adopt the following objectives:

- To provide leadership to achieve carbon neutrality in the community mitigating the effects
 of climate change, safeguarding the environment, reducing the town's carbon footprint and
 promoting sustainability
- To undertake practical measures within our powers to reduce the impact of the Council's activities on the environment, ensuring appropriate considerations inform all our decisions
- To work with all sectors of our community to develop initiatives and practical measures that will help our community towards achieving carbon neutrality, including collaboration with partners committed to ensuring carbon neutrality targets are met
- To call upon Shropshire County Council to systematically to review their services, planning regulations and Local Plans and implement measures to reduce their impact on the environment and climate breakdown
- To call upon the Government to provide regulations and resources that will enable communities to meet carbon neutrality goals by published target date/s (currently 2050).

To note completion of Carbon Literacy Project certification by the Proper Officer (May 2024, outcome awaited).

To further note delegation of Climate considerations to the Amenities & Events Committee as an integral part of the Terms of Reference of that Committee (WTC/FC/ACM/04/2425 – 15th May 2024).
