9. Small Community Grant Programme 2024-25 / Grant Funding 2023-24 Update
It was agreed to open Round 1 of the SCG Programme for 2024-25, running 15<sup>th</sup> July – 20<sup>th</sup>
September, with applications considered at the Committee Meeting scheduled for 2<sup>nd</sup>
October 2024.

A verbal update was received from the Proper Officer in relation to outstanding reports and feedback from grantees in 2023-24 funding rounds (including annual allocations), notwithstanding 'reminder/s' being issued. The Committee noted that the provision of reports and feedback was a condition of grant funding and that future support in these cases will be suspended – to be reviewed upon receipt of any outstanding obligations, by the Proper Officer, with an appropriate update being provided to Full Council. Any future annual allocations are to be re-determined by Full Council, on the advice of the Proper Officer, given a breach of Grant Funding Terms and Conditions.
